#### **It's Easy to Sign up:**

To Register for your biometric screening, go to [www.chcw.com](http://www.chcw.com) or Scan the QR Code and follow the steps to register. Registration will close once capacity is met.

- **New Participants:** Enter in program code **7137Tea154** in the "New Participants" box and select "Register." Follow the prompts to verify your personal information, sign up for a screening, and complete the Health & Lifestyle Survey.
- **Returning Participants:** Log in with your CHC username and password under "Individual Login" and select "Log in". Then complete the activity cards under "Today's Activities" on your dashboard to successfully register for your screening.
- **\$400 Wellness Incentive-** You will need to complete your Health & Lifestyle Survey to qualify for a \$400.00 wellness incentive.
- **Appointments-** You will need to schedule your blood test, Skin IO, and Health Gauge Screening services separately. Health Gauge appointments can be made by going to the Health Gauge website:

**Skin Health Assessment by Skin IO** -Did you know that skin cancer is the most common type of cancer in America? Luckily, it is easy to treat when it's caught early. Visit the Skin IO Booth, located in the Conference Center.

**Hinge Health** -You don't have to put up with joint pain. Whether you are recovering from an injury or dealing with everyday joint pain, you can get relief. Visit the Hinge Health Booth, located in the Conference Center.

**Stroke Screening by Health Gauge** -Health Gauge screening services are designed to identify risk factors that can lead to cardiovascular disease, stroke or other serious illness. Each health check takes a few minutes to conduct, and you can stay clothed and comfortable. Stop by the Health Gauge Booth located in the Conference Center to conduct your screening.

## **UNABLE TO MAKE IT TO ONE OF OUR ON-SITE EVENTS**

There are other ways to participate in the Wellness Program if you are unable to make it to one of our on-site events.

- **SCREENING THROUGH A LOCAL LAB:** VISIT A LAB BY DECEMBER 31, 2026.
  - When registering for the screening, select the “Test at a Lab” option. After completing registration and your Health & Lifestyle Survey, print or display on your telephone the two lab forms at your local LabCorp Facility.  
*Note: Blood pressure readings may not be available at all LabCorp locations.*  
*Please select "Employee Wellness with Body Measurements" when visiting [www.labcorp.com](http://www.labcorp.com) to find the facility nearest you.*
- **PHYSICIAN FORM:** VISIT YOUR DOCTOR AND SUBMIT YOUR RESULTS NO LATER THAN DECEMBER 31, 2026.
  - When registering for the screening with CHC Wellbeing, select the “Physician Form” option. After completing registration and your Health & Lifestyle Survey, print and take the form to your physician and have them fill it out. Upload your results to your CHC portal by logging in to [app.chcw.com](http://app.chcw.com) and clicking the “Upload Your Results” button OR via facsimile to CHC at (847) 437-2775.

**NOTE:** To qualify for a \$400.00 Wellness incentive in 2026, test results must be from blood drawn between 01/01/2026 and 12/31/2026. Test results from 2025 will not be considered or qualify for the 2026 incentive. If you have already received your \$400.00 wellness incentive in 2026, you will not qualify for an additional incentive in 2026.

By participating in the Wellness Program, you will also receive \$0.00 co-pays for all drugs and services through 12/31/2026 related to:

Wellness Program participation in 2026 will cover your \$0.00 co-pays for the remainder of 2026, and all of 2027, so long as you are eligible under the Plan. If you are currently receiving this valuable benefit because you participated in 2025, and do not participate again in 2026, your \$0.00 co-pays will end on 12/31/2026.
